FULL OFFICIAL RULES
OPEN ONLY TO LEGAL RESIDENTS OF THE FIFTY (50) UNITED STATES WHO ARE 18
YEARS OR OLDER AT TIME OF ENTRY
VOID WHERE PROHIBITED BY LAW

BY ENTERING, YOU AGREE TO THESE OFFICIAL RULES, WHICH ARE A BINDING CONTRACT. THIS CONTRACT INCLUDES INDEMNITIES TO THE RELEASED PARTIES FROM YOU AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

1. No Purchase Necessary: NO ENTRY FEE, PAYMENT, OR PROOF OF PURCHASE IS NECESSARY TO ENTER OR WIN. The Contest is void where prohibited by law. Must be 18 years or older at time of entry to enter.

2. To Enter: The contest described herein, including the judging of each entrant's response, shall be hereinafter referred to as the "Contest." To enter, entrants must complete and submit the online entry form located at <https://app.miamidolphins.com/2026-fan-of-the-year-presented-by-ticketmaster/>, providing the following required information: full name; email address; phone number; date of birth; and a short-answer written response explaining why the entrant should be selected as the Miami Dolphins Fan of the Year. Entrants may also, at their option, upload a photograph and/or video. The written response is required to complete entry and will serve as a basis for judging and winner selection; any optional photograph or video may also be considered by the judges. A complete entry must be received during the Contest entry period, which begins on September 21, 2026, at 1:00 PM ET, and ends on November 1, 2026, at 11:59PM ET.

Incomplete Contest entries will not be accepted. Miami Dolphins, Ltd. ("Sponsor") assumes no responsibility for incomplete, lost, stolen, late, misdirected, misplaced, mutilated, or garbled entries or communications, or for technical failures of any kind, including, without limitation, malfunctioning of any network, server, telephone, carrier service or equipment, infection by virus or bugs, or other failure. Sponsor's computer shall be the official timekeeping mechanism for the Contest.

3. Entry Requirements; Consent and Rights: Each entry, including the written response and any optional photograph or video uploaded through the online entry form (collectively, the "Entry"), must be the entrant's original work. Entrant represents and warrants that the Entry does not infringe any third-party copyright, trademark, or right of privacy or publicity, and that entrant has obtained all permissions and legally sufficient releases from any third parties depicted or identified in the Entry. 4. Prizes: The Contest will award one (1) Grand Prize to a single winner selected on the basis of skill and merit by Sponsor, consisting of two (2) tickets to Super Bowl LXI. The approximate aggregate retail value (ARV) of the Grand Prize is \$5,000.00.

All additional expenses that are not specifically included in the prize as stated above, including, but not limited to, shipping or delivery of the prize, are the winner's sole responsibility and may need to be prepaid, in part or in whole, prior to receipt of prize. The winner will be selected on the basis of skill and merit, and not by chance, from among all eligible entries received during the Contest entry period, as judged in the sole discretion of Sponsor. The decision of Sponsor is final and binding in all respects. The winner will be notified by e-mail and by public announcement.
